



## Howard Park Tennis Club Locker Rental Agreement

The following terms and conditions apply to all Howard Park Tennis Club Locker Rentals:

1. Locker Rental is subject to availability and lockers are issued on a first-come, first-served basis to Members in good standing of the Club.
2. To rent a locker, the Member must visit the Club's website, [www.howardparktennis.com](http://www.howardparktennis.com), or make arrangements in person during the season with a Court Manager. The Club accepts payments in the following methods: Visa or MasterCard (online and on-site); or cheque or money order made payable to: Howard Park Tennis Club (on-site only). **Note:** The Court Managers are not authorized to accept cash payments.
3. The Locker Rental fees are:
  - a. \$15 for a large locker; and
  - b. \$10 for a small locker.
4. The Rental fee covers Locker Rental for the current season only and the Club does not pro-rate late rentals.
5. No refunds will be issued for Locker Rental payments received.
6. Lockers are not transferable between members.
7. There is a limit of one locker per Member.
8. The rental fee is for Locker Rental only and the Member must supply his/her own lock.
9. Possession of a rented locker takes place on or after the later of:
  - a. Opening Day of the Club; or
  - b. the date payment has been received.
10. Lockers must be vacated on or before the end-of-season Closing Day of the Club in October. The exact date is shared in Club communications during the season and is posted on the Club's website: [www.howardparktennis.com](http://www.howardparktennis.com). If a locker remains occupied after Closing Day, the contents are held for a maximum of 30 days. To make arrangements to retrieve items after Closing Day and before the end of the 30-day grace period, the Member must send an email to [info@howardparktennis.com](mailto:info@howardparktennis.com). Following the 30-day grace period, the Member forfeits ownership of the locker contents. In such case, the lock is removed and the items donated or disposed of in a manner deemed appropriate by the Club.
11. Items not to be stored in the locker include: perishable or packaged food; items that may emit odors or secrete liquids; illegal or stolen items; or any other items that constitute a potential hazard or inconvenience to other Club members.
12. Howard Park Tennis Club is not responsible for the theft or loss of any goods for any reason during or after the rental period. It is the responsibility of the Member to ensure that his/her goods are stored safely and that he/she is in possession of owner's or tenant's insurance coverage that provides for the replacement of goods or possessions that may be stolen, vandalized, damaged or lost.
13. Suspected violation of any terms and conditions can result in a locker search without notice or permission and the removal of locker contents.
14. Howard Park Tennis Club may, in its sole discretion, share the results of a locker search with appropriate authorities as warranted.

By agreeing to this rental agreement and the terms and conditions therein the Member agrees to undertake all obligations and duties therein.
